Dear Ms. Rollan:

Thank you for your letter today, January 27, 2009, inviting the World Bank to the committee's second hearing on issues concerning the debarment case under the first phase of the World Bank-assisted National Roads Improvement Management Program.

We fully support the committee's endeavor to promote good governance and strengthen the country's procurement system. As you are aware however, Bank staff, as representative of an international agency, faces restrictions in attending formal hearings of parliaments in member countries.

To ensure that all stakeholders have as much information as possible, we have posted on our website information regarding the investigation and the sanctions process, a list of debarred firms worldwide, and other information relevant to this matter. We have shared all these information through your office since last week. We have been quite pleased with the way that our offices have been communicating with each other. (For your easy reference, we are attaching some of the basic documents posted on our website.)

We would like to reiterate that the World Bank's Sanctions Board came to its decisions after a careful and intensive process of investigation and evaluation. The Bank's investigative office, INT, conducted the investigation. INT is a separate Vice Presidency charged with investigating allegations of fraud and corruption in Bank-financed projects. INT reports directly to the President of the World Bank and is staffed by a team including investigators, legal specialists, forensic accountants, and others. The investigation included numerous interviews across several countries and an in-depth review of all documentation related to the bidding process under the NRIMP-1 project. The investigation found evidence that several firms and individuals may have engaged in collusion in connection with two contracts under the project. The report of the investigation was shared with the relevant authorities in the Philippines.

All of the firms and individuals in this case were given ample opportunity to defend themselves. They all received the Bank's Notice of Sanctions Proceedings in May 2008, and were given 90 days to submit a response in their defense and contest the allegations against them. The firms and individuals were also entitled, as part of their response, to request a hearing before the Bank's Sanctions Board, if they choose to do so, and some did. The Sanctions Board consists of external legal experts and senior World Bank staff. Since 1999, more than 350 firms and individuals from more than 22 countries – including the US, Sweden, the Netherlands, and the United Kingdom – have been banned from bidding for Bank-financed projects, either indefinitely or for a specific period of time.

Throughout the sanctions process, we have been in regular dialogue with oversight agencies and the Department of Public Works and Highways. Based on the experience of phase one, we have incorporated tighter security and oversight mechanisms in the second phase of the NRIMP program to ensure that both Government and World Bank money is used properly.
