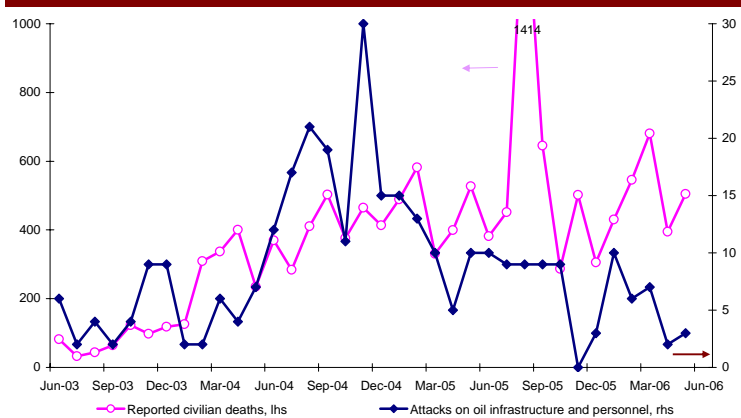

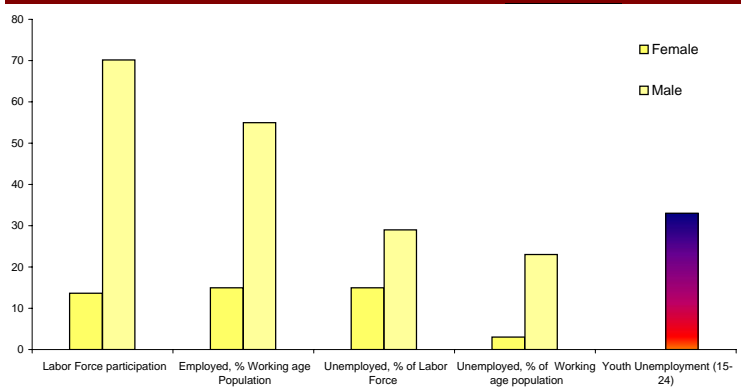

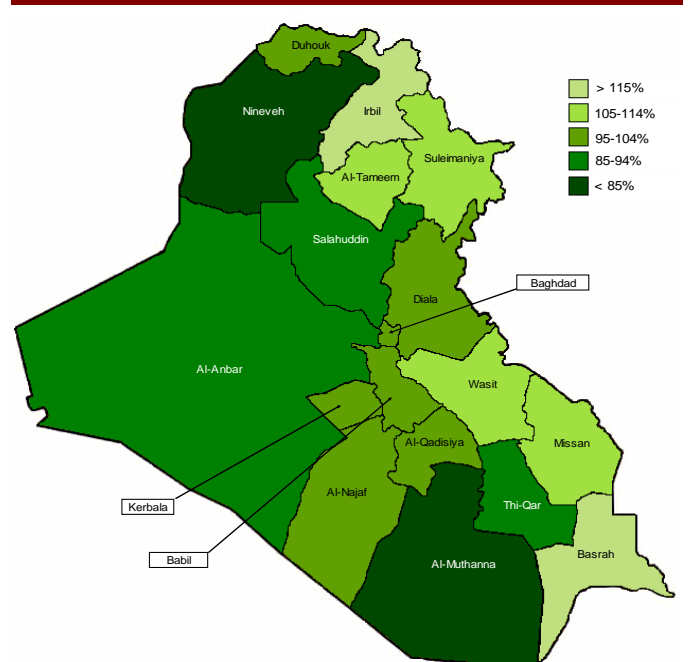
Attacks on oil infrastructure and reported civilian deaths as a result of acts of war¹



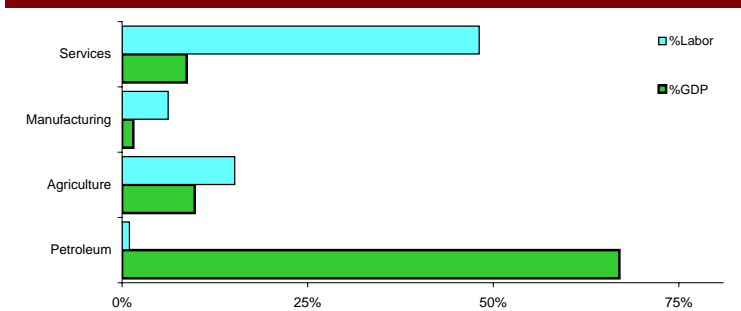
Labor Force and Unemployment 2004e²

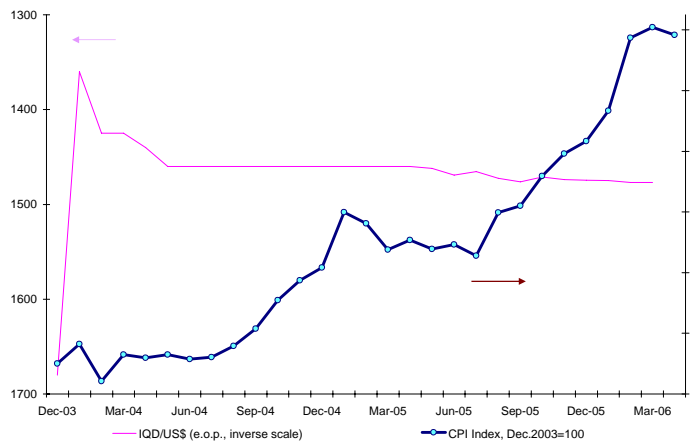

Gasoline: ratio of black market price to official price, April 2006⁵

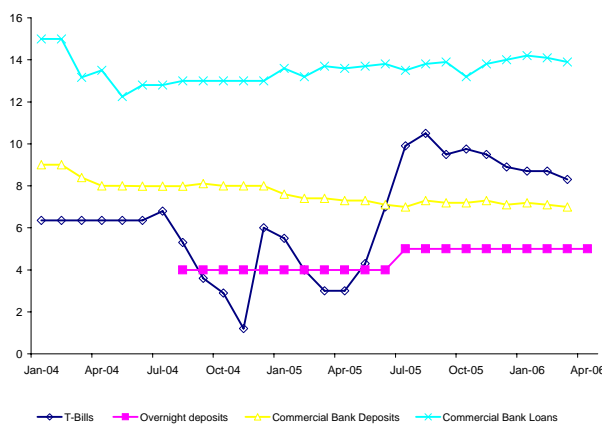

Exchange rate and consumer price index

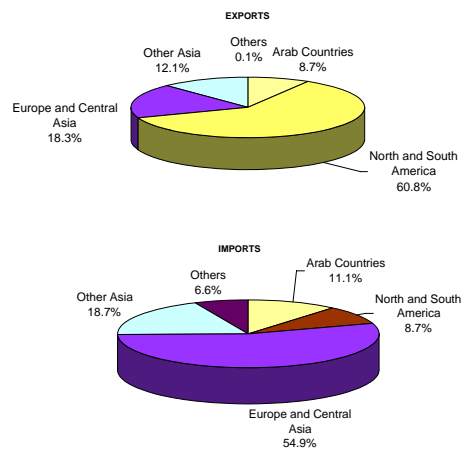

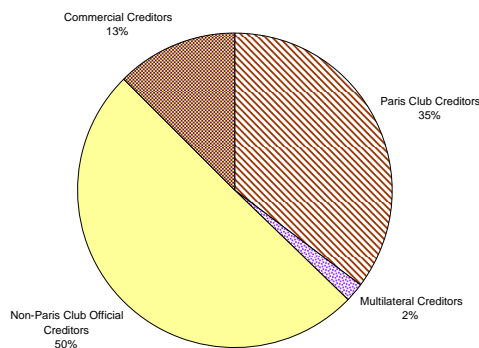

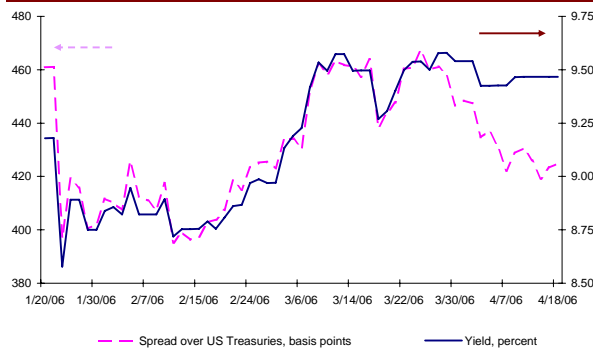
External Public Debt, December 31, 2005 (% of total)
