- The General *Avvocatura* has its seat in Rome while the 25 District *Avvocature* have their seats in each Region, precisely in each seat of Court of Appeal.

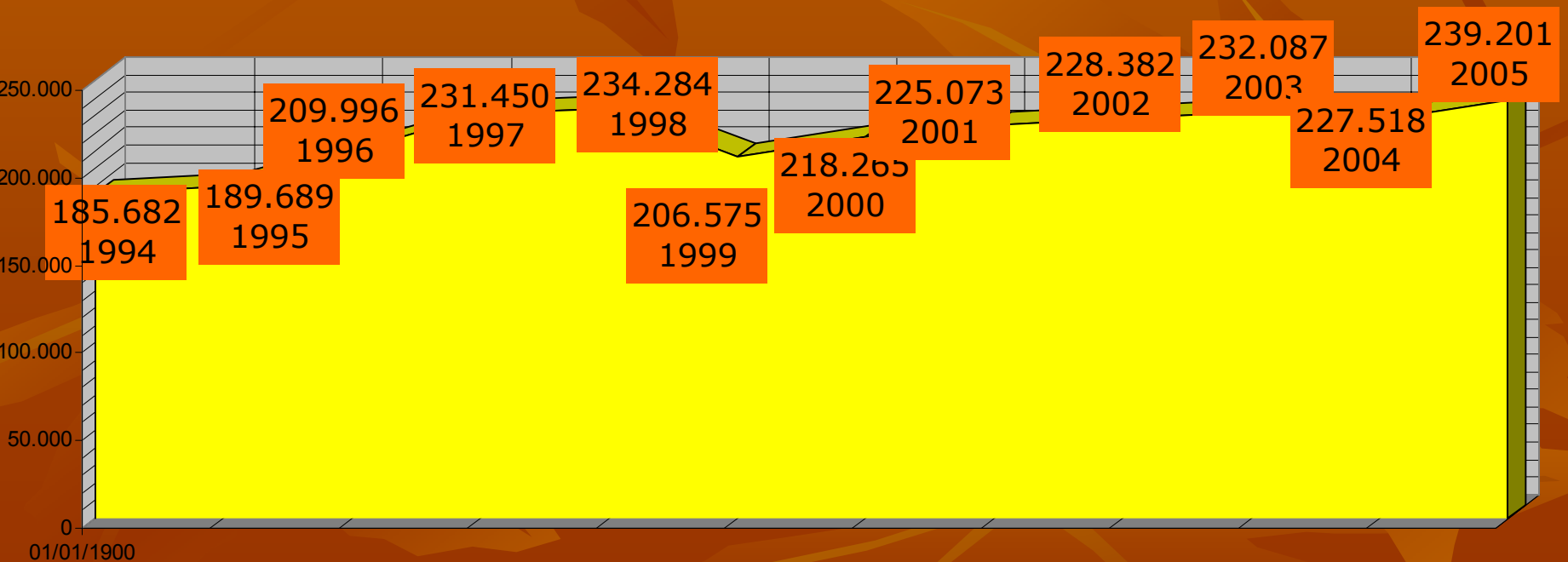

# Avvocatura dello Stato: trend of the judiciary and consultive activity

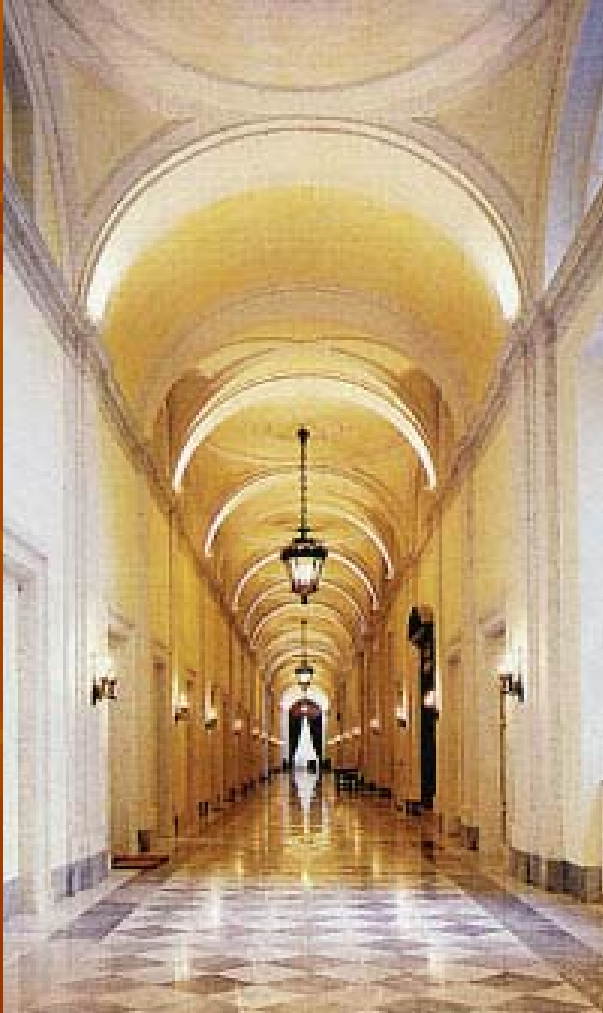

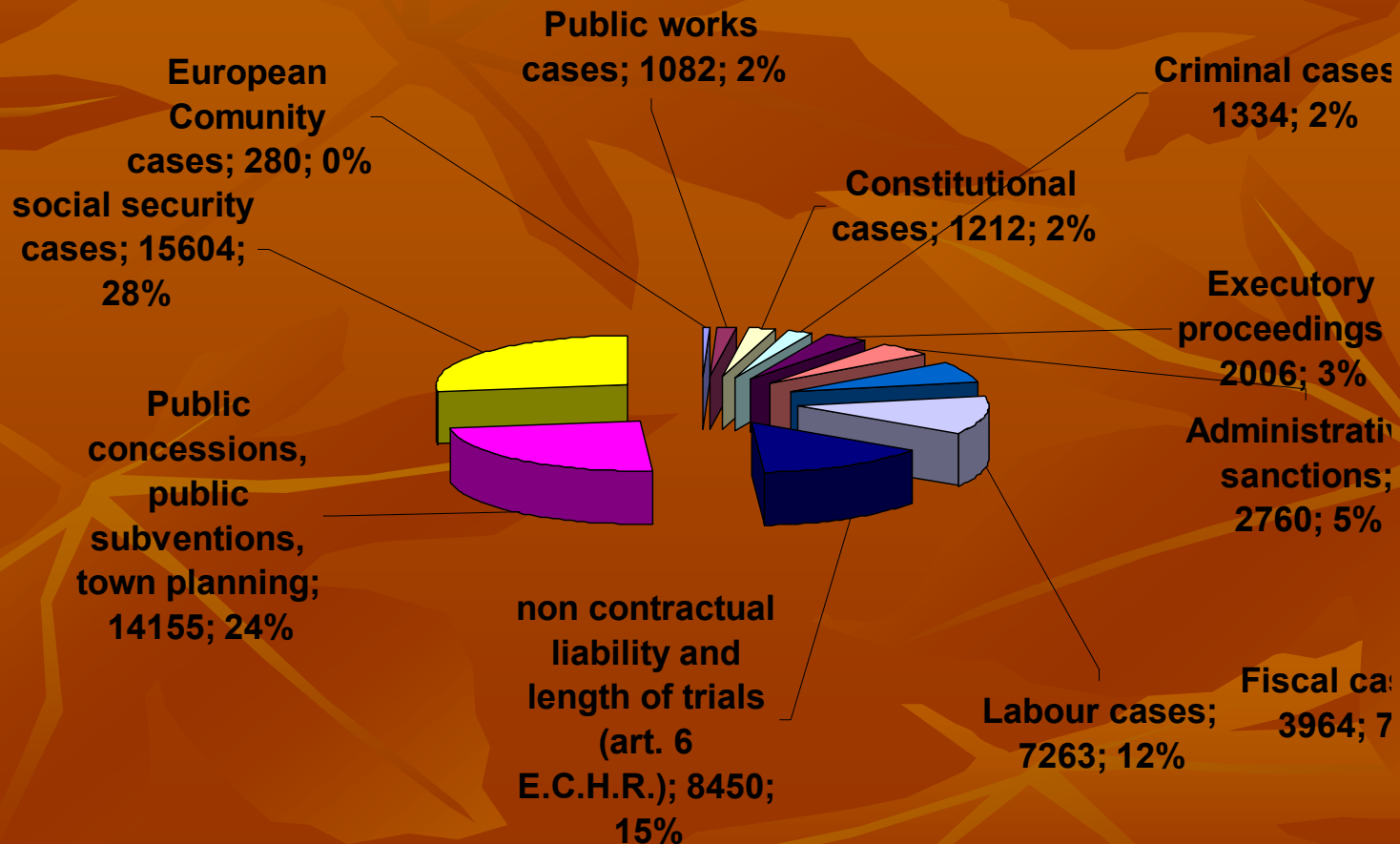

# Avvocatura Generale



- The seat of Rome is divided in 8 sections, each of them directed by a Deputy Attorney General and dealing with a certain number of administrations.
- The Attorney General coordinates and directs the institutional activity;
- He directly supervises the most important juridical matters: European Community law, Constitutional law, Independent Authorities.
- For the administrative functions, the Attorney general is assisted by the Secretary General, the State Lawyer Council and the Executive Board
